Sign Language Interpreter will be empanelled on honorarium basis (@ Rs. 22,000/- per month for a maximum period ending 30<sup>th</sup> May, 2020 or till further orders. The empanelment will be purely on honorarium basis and no claim for regular appointment shall be entertained by the University at any time.

Interested and eligible candidates are required to report for Walk-in-Interview at their own expense in the O/o The Vice-Chancellor, 5<sup>th</sup> Floor, Admin Block, Conference Hall as per given schedule along with the following documents:

1. Original certificates of relevant degrees and experiences with two sets of photocopies.
2. Three passport size photographs with proof of identification.

### **Important Instructions:-**

1. Interested and eligible candidates are requested to fill the prescribed Application Form and bring the same with all the annexures along with original certificates and testimonials for personal interview, as per schedule indicated above.
2. For empanelment, due weightage shall be given to academic merit (marks percentage), teaching experience as well as their research qualifications/paper publication etc.
3. Candidates are required to bring a bank draft of Rs. 500/- drawn in favour of Finance Officer, Dr. Shakuntala Misra National Rehabilitation University, Lucknow, self attested photocopies of relevant degree and experience certificates, publications, passport size photographs along with proof of identification at the time of Interview, failing which they shall not be allowed to appear in the interview.
