Sir/Madam,

It may be informed that NCTE has been in the process of compiling a data base on Teacher Education Institutions (TEIs) which are compliant with the NCTE Act and NCTE Regulations, 2014. Towards this end, all recognized TEIs were directed to file an affidavit listing out all necessary details. Thereafter, Show Cause Notice was issued to all TEIs who had not filed the Mandatory Affidavit. As a result of this exercise, a list of TEIs which are deemed to be provisionally compliant (pending verification of their claims), has been placed on the NCTE website : www.ncte-india.org.

Furthermore, a list of certain TEIs with list of courses is also placed on our website titled "Newly Recognized Courses". Admissions may be allowed in these courses in these TEIs as these have been recognized by NCTE after the last date for submitting affidavit (i.e. 12.12.2016) and the institution did not have any opportunity to file the same.

To deter TEIs, which are prima-facie non compliant, from admitting students for the academic session 2017-18, a Public Notice dated 17.06.2017 has been issued through newspaper advertisements across the country (copies enclosed for reference). You are requested to take cognizance of our Public Notice and also ensure that TEIs who are not in the list are not able to admit students.
