### Walk-In-Interviews for Empanelment as Guest Faculty

Dr. Shakuntala Misra National Rehabilitation University, Lucknow is looking for dedicated and qualified persons for the position of Sign Language Interpreter, Guest Faculty & Speech-Language Pathologist/ Audiologist-Grade I & II on lecture basis/Fixed honorarium.

**Walk-in-Interviews** will be conducted for empanelment of Sign Language Interpreter, Guest Faculty & Speech-Language Pathologist/ Audiologist-Grade I & II in various faculties/ departments of the University as per details given below.

Sign Language Interpreter & Speech-Language Pathologist/ Audiologist-Grade I & II will be empanelled on fixed honorarium basis. Guest Faculty on lecture basis (@ Rs. 400/- per lecture, maximum 3 lectures in a day or @ Rs. 175/- per hour for non-teaching academic work, subject to maximum of Rs. 25,000/- per month) ending 30<sup>th</sup> May, 2021 or filling up of posts through regular recruitment or till further orders, whichever may be earlier. The empanelment will be purely on lecture/hourly basis and no claim for regular appointment shall be entertained by the University at any time.

1. Original certificates of relevant degrees and experiences with two sets of photocopies.
2. Three passport size photographs with proof of identification.



**Important Instructions:-**

1. Interested and eligible candidates are requested to fill the prescribed Application Form and bring the same with all the annexure along with original certificates and testimonials for personal interview, as per schedule indicated above.
2. The maximum age limit for applicants shall be 70 years.
3. For empanelment of Guest Faculty, due weightage shall be given to academic merit (marks percentage), teaching experience as well as their research qualifications/ paper publication etc.
4. The last date for submission of applications is 30<sup>th</sup> March, 2021 (5:00 p.m.)
5. Candidates are required to bring a bank draft of Rs. 500/- drawn in favour of Finance Officer, DSMNRU Lucknow, self attested photocopies of relevant degree and experience certificates, publications, passport size photographs along with proof of identification at the time of Interview. Failing which they shall not be allowed to appear in the interview. The candidates are also required to mail the duly filled-in scanned application form on e-mail: [dsmnruepanelment2019@gmail.com](mailto:dsmnruepanelment2019@gmail.com) on or before the last date.
6. Applicants must fully satisfy themselves about their eligibility and qualifications, as prescribed in the referred advertisement, before appearing in the Interview. If an applicant is inadvertently allowed to appear in the Interview, who otherwise does not fulfil the minimum eligibility requirements, he/she cannot use that as right, at any stage, to claim his empanelment against any faculty position advertised.

8. The results of Walk-in-Interview shall be notified through Notice Board/University website after approval of the competent authority. No separate correspondence shall be entertained during the process of empanelment.
9. Candidates are required to make their own arrangement for stay. No TA/DA shall be paid for attending the interview.
