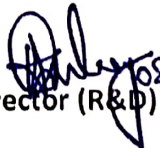

Guidelines for Research and Academic Excellence Award

1. Definition

1.1 This guideline will be known as "Guidelines for Research and Academic Excellence Award" of the University.

1.2 Faculty Member- Permanent/ Regular Faculty Members of the University.

1.3 Research Scholar- Ph. D. Research Scholar enrolled in the University.

2. Objectives

2.1 To promote research and academic excellence in the University.

2.2 To inspire other faculty members and research scholars to contribute in the field of research and academics

2.3 To establish this Institution as a Centre for Excellence in the field of academics and research

3. Frequency

3.1 This award will be given on yearly basis based on the research and academic contribution of the Faculty Members and the Ph.D. Research Scholars

4. Category of Award at each Academic Level

4.1 One Professor of the University in each broad discipline

4.2 One Associate Professor of the University in each broad discipline

4.3 One Assistant Professor of the University in each broad discipline

4.4 One Research Scholar enrolled in each broad discipline.

5. Categorisation of Group of Departments/ Faculty as Broad Disciplines

The various Departments/Faculty of the University have been grouped into following three broad disciplines. These are:

5.1 Faculty of Arts, Humanities & Social Sciences; Languages, Fine Arts and Performing Arts

5.2 Faculty of Special Education; Para Medical Rehabilitation Sciences, Commerce, Law

5.3 Faculty of Science, Engineering & Technology, Pharmacy

6. Application for the Award

6.1 All the Permanent/ Regular Faculty Members of the University and Research Scholar enrolled in the University can apply for the Award in the format prescribed by the University (see Annexure- 1)

6.2 While applying for the award the applicant should mention the following:

- I. Research Publications in UGC-CARE, SCOPUS/SCI/Web of Sciences/SSCI indexed Journals
- II. Books Published/ Edited
- III. Chapter in edited books
- IV. Resource and fund Generation through projects (in INR)
- V. No. of Patents Granted
- VI. No. of Policy document developed
- VII. No. of MOOCs developed as per NEP
- VIII. No. of Contribution to implementation of SWAYAM courses
- IX. Google Scholar Citations

7. Screening of the Application

7.1 The screening of the applications received for the award will be done by a Screening Committee formed by the Hon'ble Vice- Chancellor of the University.

7.2 Calculation of the research score will be done according to the following criteria:

7.2.1 Research papers publications

In this category, the research papers published only in UGC-CARE, SCOPUS/SCI/Web of Sciences/SSCI indexed journal shall be listed for calculating the score as per following:

- Paper without impact factor – 15 marks/ paper
- Paper with impact factor < 1 – 20 marks/paper
- Paper with impact factor $\geq 1 < 2$ – 25 marks/paper
- Paper with impact factor $\geq 2 < 5$ – 30 marks/ paper
- Paper with impact factor $\geq 5 < 10$ – 35 marks/ paper
- Paper with impact factor ≥ 10 – 40 marks/ paper

Impact factor to be determined as per Thomson Reuters list presently being know as Clarivate Analytics.

For 02 authors: 70% of the total marks for each author.



For more than 02 authors: 70% of the total marks for First/Corresponding/Principal author (supervisor) and 30% for each of the joint authors.

7.2.2 Publications other than Research Papers

- Books authored & published by International Publishers – 12 marks/ book.
- Books authored & published by National publishers– 10 marks/ book.
- Editor of book/chapter in edited book published by International publishers– 10 marks/ each.
- Editor of book/chapter in edited book published by National publishers– 8 marks/each.

7.2.3 Research Projects obtained with DSMNRU Affiliation (funding to be received in DSMNRU account):

- Completed: Less than 10 lakhs – 5 marks; 10 lakhs and above – 10 marks
- Ongoing: Less than 10 lakhs – 2 marks; 10 lakhs and above – 5 marks
- For joint project with 2 Investigators: 50% of the score shall be shared by each one
- For joint project with more than 2 Investigators 70% for PI and 30% for each Co-PI.

7.2.4 Patents (granted only) in which DSMNRU must be the participating Institution for IPR.

- International Patent – 10 marks.
- National Patent – 7 marks.
- For 2 Inventors: 50% marks for each.
- For more than 2 Inventors: 70 % marks of Principal-Inventor and 30% for each co-Inventors.

7.2.5 Policy Document submitted to an International Body/Organization like UNO/UNESCO/World Bank/International Monetary Fund etc. or Central Government or State Government

- International – 10 marks
- National – 7 marks
- State – 4 marks

7.2.6 Contribution to Implementation of SWAYAM courses

- Implementation in one semester course of 3/4 credit – 10 marks
- Implementation in each semester throughout the programme – 20 marks

7.2.7 Contribution to develop MOOCs course

- Complete 4 module course of MOOCs of 4 credit – 20 marks
- MOOCs per module – 5 marks

Content writer/subject matter expert for each module of MOOCs (at least one module) – 2 marks

7.3 The faculty/scholars, who claim google scholar citations, will have to give an undertaking that his/her claim is verified and true. It shall be excluding self citation. In case, later on, if the claim found false, the award may be withdrawn from the concerned awardee and appropriate action shall be taken against him/her.

7.4 Each awardee shall be given a certificate and case price Rs. 2500.
