**ABOUT THE UNIVERSITY**

Dr. Shakuntala Misra National Rehabilitation University, Lucknow was established by the Government of Uttar Pradesh in 2008 vide UPVU Dr. Shakuntala Misra University Act, 2008 (Act. No. 1 of 2009) under the Department of Empowerment of Persons with Disabilities, Government of Uttar Pradesh. The University is recognised by the University Grants Commission under Section 12(B) of UGC Act, and affiliation of its programs is from various affiliating bodies such as Bar Council of India (BCI), Rehabilitation Council of India (RCI), All India Council for Technical Education (AICTE) and Association of Indian Universities (AIU) among others. **According to the Nature Index, our university demonstrates exceptional research productivity, securing the 2<sup>nd</sup> position in overall research output. Furthermore, we are ranked 162<sup>nd</sup> among the Indian universities.**

Being the first of its kind in India, the University provides opportunity of learning to the students with special needs in a seamless and sensitive academic environment. It offers accessible and world class higher education to all with an inclusive approach. The University is committed to set new standards in higher education by offering universal access to quality education. One of the most distinctive features of this University is that there is a provision of reservation of fifty per-cent (50%) seats for Persons with Disability (Divyangjan) in all the programs run by the University. Out of the fifty per-cent seats reserved for the Divyangjan fifty per-cent seats [i.e. twenty-five per-cent (25%) of the total seats] are reserved for visually impaired persons. In a short span of Time, the University has earned the status of an innovation-driven institution that proactively brings together academia and industry with a sense of social responsibility. Dr. Shakuntala Misra National Rehabilitation University is currently offering various programs under six faculties and one Institute. The University has initiated modern teaching pedagogies to cater the special requirements of differently abled students by offering facilities such as sign language interpretation for deaf, Braille Books for students with visual impairment etc. All programs are being administered with international teaching and research standards to provide quality education to the students enrolled in the University.

The barrier-free University campus is spread over 156 acres of land in Lucknow, the state capital of Uttar Pradesh. The University has also received National Award for its outstanding contribution in providing barrier-free environment from Hon'ble President of India, Shri Pranab Mukherjee in 2014.

The allied facilities of the University which includes Bank, Post Office, Students Hostel (Boys' & Girls'), Canteen, Guest House, Staff Quarters, Computer Centre, Placement Cell makes it a self-sufficient academic microcosm.

The University encourages inter-disciplinary and multi-disciplinary approach for holistic academic development of faculty and students alike. The dedicated and distinguished faculty with wide exposure in their respective disciplines make for lively transaction of knowledge and vibrant class room atmosphere. The curricula of various programs in the University are designed to meet the best international standards. The uniqueness of the University lies in imparting quality education based on international parameters and the paradigm of inclusive empowerment of Divyangjan. The University firmly believes that knowledge and comprehensiveness are glorious attributes of a civilized society. Hence, our endeavour is to educate and inculcate moral values in students for making them responsible individuals and virtuous citizens. The University also aims to arouse the social consciousness among students and to provide them with opportunities to utilise their education for social welfare. In keeping with its commitment, the University has adopted Tuberculosis (TB) and leprosy individuals and is constructively engaged in bringing them back to the mainstream. These efforts on the part of the University play a vital role in enhancing the personality and experience of the students.

The University provides free hostel and mess facilities to the divyang students as per norms. The Centre for Indian Sign Language and Deaf Studies has been established with a view to cater the educational needs of the deaf students. A special feature of this centre is two years Pre-Degree Certificate Program (PDCD) for the Deaf Students, equivalent to the Intermediate under 10+2 pattern, which is duly recognized by the Board of High School and Intermediate Education, Uttar Pradesh. Another important endeavour of the University is the establishment of the Artificial Limb and Rehabilitation Centre which manufactures artificial limbs and provides the same to the Divyangjan free of cost. The University also runs allied health science programs such as, four years' Bachelor of Audiology and Speech Language Pathology (BASLP) and four and a half years' Bachelor of Prosthetics and Orthotics (BPO).

The University has established various cells, viz, the Guidance and Counselling Cell, Sports and Yoga Cell, University Industry Linkage Cell and a Cultural Cell. These cells have been established with a purpose of developing and moulding the overall personality of the students. The University has also started a College for the Deaf from this session, which is the only college for the Deaf in Northern India. Under this college many short-term vocational courses have started and an MOU with NIELIT, Government of India has been signed. The university also has an international badminton hall with TURF facility its own special mini stadium with the facilities of gym, badminton court and other sports related facilities especially designed for the Persons with Disabilities. There is an ongoing endeavour to expand University-Industry Interface and upgrade in-house capabilities to conduct professional and job-oriented programs which are compatible with the emerging trends of economy and employment.

Many students of this University have got placements in various government/ non-government/ public/ private sector undertakings of national and international repute like higher education commission, Indian Statistical Services, Provincial Civil Services, Allied Services, HDFC Bank, ICICI Bank, Axis Bank, PNB, SBI, Pantaloon, Future Group, Reliance Communications, Airtel, Vodafone etc. The University is geared to prepare the students for a dignified and quality life through effective delivery of educational services along with an integrated and inclusive approach in imparting life skills to the students. Building proactive and meaningful academic atmosphere to provide high quality, relevant and responsive learning environment for one and all and the integration of students into global socio-economic mainstream is at the top of the University agenda.

## FACILITIES AND SERVICES

The infrastructural and educational environment of Dr. Shakuntala Misra National Rehabilitation University includes multimedia educational approach through technology-friendly smart classrooms with modern audio-visual educational aids like Computers, CCTV and Projectors etc. The university has well equipped computer lab with JAWS (Job Access with Speech). All these along with the green eco-friendly campus combine to offer the student a world-class educational experience for their all-round development. The other allied facilities of the University include:

### Hostel Facility



The University provides hostel facility for both boys and girls which are very spacious and well-ventilated. Attendants are provided to the disabled students for managing their daily affairs. There is constant supervision and monitoring of the students' activities and emphasis is laid on their safety. Medical & Health services are also provided in the campus for the students residing in the hostels. The "Sawasthya Sewa Kendra" adjacent to the hostel block provides medical services to the hostellers round the clock in case of any casualty/emergency.



### Sports and Games Facility



Indoor and outdoor international level stadiums are available in the university campus which are equipped with sports equipment of international standards. The indoor stadium is especially designed for the persons with Disabilities. Its design and facilities are the main USP of the stadium. The stadium is equipped with TURF facility, wooden flooring, international standard badminton court, judo, table tennis, gym and many other facilities. The outdoor stadium is designed for track and field games, football, hockey, volleyball and cricket.



### Central Library



The Library in the University caters to the students with a rich collection of international and national books, journals, reports and reading material on a wide range of subjects. Braille books are also available for the visually impaired student. Many computers in the library are equipped with screen reading softwares which can translate the text into 146 languages and read it out to the students specially the visually impaired ones. The library is connected to campus wide network and terminals for users.



### Bank, ATM facility and Post Office



Dr. Shakuntala Misra National Rehabilitation University, Lucknow Uttar Pradesh has a Branch of Bank of Baroda, a nationalised bank established inside the campus with the motive of providing an easy access to financial services to the students especially the Divyangjan. ATM of two different banks, Bank of Baroda and Punjab National Bank are functional in the campus. A Post Office is also established in the campus.

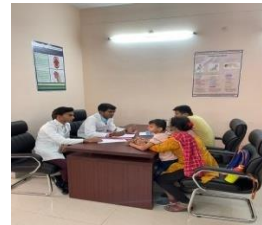


### Canteen

The Canteen has been designed with barrier-free features keeping in view the needs of the disabled persons. The Canteen offers food products at affordable prices and it remains open throughout the week. It is a popular hangout for students.

### Medical Facilities

Medical & Health services are also provided in the campus for the students. There is a provision of "Sawasthya Sewa Kendra" for the students just adjacent to the hostel block which provides medical services to the students in case of any casualty/emergency. Each and every student is insured under Group Insurance Cover. The University also has its own Chief Medical Superintendent (CMS), who looks after the medical facilities.



### Physiotherapy Unit

The University has its own Physiotherapy Unit equipped with ultramodern & digital therapeutic instruments. This unit provides assessment, diagnostic, therapeutic and consultation Services to those who need it, free of cost to every students and staff of the University.

### Artificial Limb and Rehabilitation Centre

To meet the increasing demand of providing highest quality Prosthetics & Orthotics and Rehabilitation Care to the physically challenged persons, the University has set-up an Artificial limb and Rehabilitation Centre (ALRC) in its premises. This centre takes up the activities of providing Clinical Services, conducting outreach programs, engages itself in Research & Development Activities and also run training programs in the field of Prosthetics and Orthotics.



### Audiology and Speech-Language Pathology Clinical Services

The University has also established an Audiology and Speech- Language Pathology related clinical services in its premises, which provides free of cost assessment and management of patients with various Speech and Hearing related disorders such as Voice Disorders, Cleft Lip and/or Palate, Delayed Speech and Language Disorders, Stuttering, Articulation problems, Audiological evaluation, Hearing Aid fitting and others.

### Talking Book Studio

Talking Book Studio is a special feature for the visually impaired students. It has facilities for providing recorded notes/lectures and audio books. The University has signed an MoU with the Daisy Forum of India/Sugamya Pustakalaya. As per norms of the regulatory body adequate books are available in accessible format.



### Braille Press

Students with visual impairment need books and other study materials in accessible format and that is why University has established Braille Press in the campus. Students with visual impairment get books and other study materials as per their requirement.

### Well Equipped Research Laboratories

Our University have a well-equipped, research-oriented laboratory designed to facilitate a wide range of investigations. This facility houses both fundamental and advanced equipment, enabling comprehensive studies. This robust infrastructure supports our commitment to cutting-edge research and provides an optimal environment for scientific discovery.

### **Minimum eligibility requirement for the UG Programmes and Process of Admission**

Senior Secondary School Certificate or Higher Secondary (12<sup>th</sup> Grade) Certificate obtained after successful completion of Grade 12 or equivalent stage of education corresponding to Level – 4 of NHEQF.

- **Admission Procedure:** University shall notify an Admission-Brochure well in advance on the University website specifying the subject/discipline-wise number of seats for admission, criteria for admission, the procedure for admission, and all other information relevant for the candidates. The admission of Indian national students to the four year UG Programmes shall be based on merit determined on the basis of performance in the qualifying examination or the Undergraduate Entrance Test i.e. CUET-UG whichever is opted by the University from time to time. However, Foreign Nationals applying for admission through authorized channels shall be eligible for direct admission on super numeric seats. Affiliated colleges have to follow the university portal for the admission process without diluting the minimum eligibility required for admission with the approval of the University.
- **Reservation Policy:** Reservation policy in admission prescribed as per the Act & Statute of the University and the policy of U.P. Government shall be implemented.  
The Scheduled Castes/ Scheduled Tribes/ Other Backward Classes (Non-Creamy layer)/ EWS candidates originally belonging to Uttar Pradesh will be given the benefit of reservation. Scheduled Castes/ Scheduled Tribes/ Other Backward Classes/ EWS candidates of other States will be treated as unreserved category.
- **Order of Merit:** If two or more candidates have secured equivalent marks/ rank in the merit Index, then the merit for admission will be determined as follows:
  - a) The candidate, who has secured higher percentage of marks at Intermediate (10+2) or equivalent examination or polytechnic diploma, will be given preference.
  - b) If the marks secured in class (10+2) or equivalent examination or polytechnic diploma are the same in such cases first preference will be given to the candidate who has secured higher percentage of marks at High School or equivalent examination.
  - c) If the marks obtained at the High School or equivalent examination are also the same, then in that case the elder candidate (as per the date of birth) will be given priority.

**Declaration of Merit:** Merit list for admission shall be published on the official website of Dr. Shakuntala Misra National Rehabilitation University, Lucknow.

**Weightages :** Weightages for admission shall be according to the rules of the University.

#### **Duration of the Programme**

- i. The duration of the UG Programme is 4 years or 8 semesters and the maximum duration to complete the Programme shall be 7 years. Students who desire to undergo a 3-year UG Programme will be allowed to exit after completion of the 3<sup>rd</sup> year. If a student wants to leave after the completion of the first or second year, the student will be given a UG Certificate or UG Diploma, respectively, provided they secure the prescribed number of credits and fulfill the condition prescribed in this Regulation.
- ii. Students who exit with a UG certificate or UG diploma are permitted to re-enter within three years and complete the Degree Programme provided the total duration for completing the Programme shall not exceed 7 years.
- iii. Students may be permitted to take a break from the study during the period of study but the total duration for completing the Programme shall not exceed 7 years.

**In case the student wishes to exit after completion of one year of the four Year degree Programme, he/ she shall be eligible for award of a UG Certificate, provided the student fulfills the following conditions:**

- Has pursued the prescribed courses of study and has completed 40 credits as prescribed under this regulation without 'F' or 'Ab' in any course.
- Has completed, in addition, an skill enhancement course/internship/ vocational course of 4 credits during the summer vacation after the second semester; otherwise he/she shall not be eligible for re-entry in the future.
- Obtained a minimum CGPA of 4.0
- Paid all the dues of the University.
- No disciplinary proceedings are pending against him/ her.
- Any other condition, as notified by the competent authority of the University.

In case the student wishes to exit after completion of two years of the four Year degree Programme, he/ she shall be eligible for award of a UG Diploma, provided the student fulfills the following conditions:

- i. Has pursued the prescribed courses of study and has completed 80 credits as prescribed in this regulations without 'F' or 'Ab' in any course.
- ii. Has completed, in addition, skill enhancement course/internship/ vocational course of 4 credits during the summer vacation after the fourth semester; otherwise he/she shall not be eligible for re-entry in the future.
- iii. Obtained a minimum CGPA of 4.0.
- iv. Paid all the dues of the University.
- v. No disciplinary proceedings are pending against him/ her.
- vi. Any other condition, as notified by the competent authority of the University.

In case the student wishes to exit after completion of three years of the four Year degree Programme, he/she shall be eligible for award of an UG degree, provided the student fulfills the following conditions:

- i. Has pursued the prescribed courses of study and has completed 120 credits as prescribed under this regulation without 'F' or 'Ab' in any course.
- ii. Obtained a minimum CGPA of 4.0.
- iii. Paid all the dues of the University.
- iv. No disciplinary proceedings are pending against him/ her.
- v. Any other condition, as notified by the competent authority of the University.

**Lateral Entry**

Lateral entry for the candidate with UG Certificate and UG Diploma shall be allowed in the beginning of the 3<sup>rd</sup> and 5<sup>th</sup> semester respectively on the vacant seats in the programme/ or over and above the 10% of the sanctioned seats whichever is larger.

**Eligibility criteria for the PG Programme**

**1-year PG Programme:** The candidate having a bachelor's degree with Honors/ Honors with Research with a minimum of 160 credits.

**For 2-year PG Programme:** The candidate having a 3-year/6-semester bachelor's degree with a minimum of 120 credits.

The candidate having a 4-year Bachelor's degree (e.g. B.E., B. Tech. etc.) with a minimum of 160 credits shall be eligible for a 2-year/4-semester PG Programme (e.g. M.E., M. Tech. etc.).

A student is eligible for a PG Programme in a discipline corresponding to either major or minor(s) discipline in UG Programme. In this case, the University can admit the students in the PG Programme based on the student's performance in the UG Programme or through an entrance examination.

The admission of Indian nationals to the 2-year/or 1-year PG Programmes shall be based on merit determined on the basis of performance in the qualifying examination as detailed in clause 4.0 of this Regulation/ or the Postgraduate Entrance Test/CUET-PG whichever is opted by the University from time to time. However, Foreign Nationals applying for admission through authorized channels shall be eligible for direct admission on super numeric seats. Affiliated colleges may design their own admission process without diluting the minimum eligibility required for admission with the approval of the University.

a) **Reservation Policy:** Reservation policy in admission prescribed as per the Act & Statute of the University and the policy of U.P. Government shall be implemented.

The Scheduled Castes/ Scheduled Tribes/ Other Backward Classes (Non-Creamy layer)/ EWS candidates originally belonging to Uttar Pradesh will be given the benefit of reservation. Scheduled Castes/ Scheduled Tribes/ Other Backward Classes/ EWS candidates of other States will be treated as unreserved category.

**Weightages :** Weightages for admission shall be according to the rules of the University.

**Duration of the Programme**

- The duration of the 2-year/4 semester PG Programme is 2-years/4 semesters as reflected from its name and the maximum duration to complete the Programme shall be 4 years. If a student wants to exit after the completion of the first year, then he/she will be given a PG Diploma provided he/she secures the prescribed number of credits and fulfills the condition prescribed in this Regulation.

- a) Has pursued the prescribed courses of study and has completed 40 credits as prescribed under this regulation without 'F' or 'Ab' in any course.
- b) Has completed, in addition, a skill enhancement course/internship/ vocational course of 4 credits during the summer vacation after the second semester; otherwise he/she shall not be eligible for re-entry in the future.
- c) Obtained a minimum CGPA of 4.0
- d) Paid all the dues of the University.
- e) No disciplinary proceedings are pending against him/ her.
- f) Any other condition, as notified by the competent authority of the University.

**Lateral Entry**

Lateral entry for the candidate with PG Diploma shall be allowed in the beginning of the 3<sup>rd</sup> semester on the vacant seats in the programme/ or over and above the 10% of the sanctioned seats whichever is larger.

23. In case of any dispute regarding admission, decision of the University will be final and binding upon the candidates.

26. If two or more candidates have secured equivalent marks/ rank in the merit list, then the priority between them will be determined as per the following provisions-
- A. If the marks secured by the applicants in the entrance test are same, in such a case first priority will be given to the candidate who has secured higher percentage of marks in graduation or equivalent examination.
  - B. If the marks secured by the applicants in the entrance test and graduation are same, in such a case first priority will be given to the candidate who has secured higher percentage of marks in 10+2 or equivalent examination.
  - C. If the marks secured by the applicants in the 10+2 or equivalent examination are same, in such a case first priority will be given to the candidate who has secured higher percentage of marks in high school or equivalent examination.
  - D. If the marks secured at the high school or equivalent examination are also the same, in such a case the candidate who is older in age will be given priority.

  - (स) यदि अभ्यर्थियों के कक्षा 10+2 या समकक्ष परीक्षा में प्राप्त अंक भी बराबर हैं तो ऐसी स्थिति में पहली वरीयता उस अभ्यर्थी को दी जायेगी जिसने हाई स्कूल या समकक्ष परीक्षा में उच्चतर प्रतिशत प्राप्त किये हैं।
  - (द) यदि हाई स्कूल में प्राप्त अंक भी बराबर है तो ऐसी स्थिति में आयु में वरिष्ठ अभ्यर्थी को वरीयता दी जायेगी।
27. Candidates applying for admission to second post-graduate program should have secured at least 65 per cent program in the first post-graduate program and they will be considered only after the approval of Hon'ble Vice-Chancellor of the University on the basis of merit. Such students will not be provided Hostel facility.

**PART I : GENERAL**

**1. Title**

These rules may be collectively called as 'Admission Rules & Standard Procedures- 2025' along with all Annexure & Schedules.

**2. Scope & Purpose**

- a. These rules are brought to enforcement for the purpose of regulation of admission of students for a Programme of study for a degree or diploma from 'Academic Session 2025-26' onwards.
- b. These rules shall be applicable *mutatis mutandis* on all Programmes under university's administration in Academic Session 2025-26 and Programmes proposed to be administered from Academic Session 2025-26, *if any*, and afterwards.
- c. These rules are *complementary and supplementary* to the admission related rules or regulations, prescribed by statutory authorities for regulation of admission to Programmes specific to such regulatory authority, if any.
- d. The university *reserves right to amend, substitute or repeal* these rules or any part thereof, with prior publication of appropriate information.

**3. Savings**

- a. All disputes concerning interpretation or implementation of these rules shall be referred to Vice-chancellor through and on recommendation of 'Departmental Admissions Committee' constituted for the purposes of admission to Programmes under such departments.
- b. All disputes concerning 'Admission Rules & Standard Procedures- 2025' or any matter connected therewith or incidental thereto shall be subject to 'Lucknow' jurisdiction only.
- c. In cases (s) of any incidental conflict of opinions; as to interpretation or application of these rules, the opinion of Vice-chancellor or any officer of the university nominated under such authority, shall be final and binding.
- d. All admissions will be at the sole discretion of the university and mere fulfillment of eligibilities under these rules or under any other law for the time being in force, shall not establish a right to claim admission to a Programme of study for a degree or diploma.

**PART II : ELIGIBILITIES FOR ADMISSION**

**Academic Eligibility for Admissions**

- a. All candidates willing to pursue a Programme of study for a degree or diploma under the academic administration of Dr. Shakuntala Misra National Rehabilitation University, Lucknow shall be bound to possess 'minimum academic eligibility' prescribed for such Programmes in '**Admission Brochure**' subject to modification from time to time.
- b. All candidates willing to pursue a Programme of study for a degree or diploma which is regulated by a statutory authority established under the sanctity of Central or State government, shall be bound to adhere to all such specific requirements. In whatsoever form desired, through rules/regulations/circulars/orders or notifications of such statutory regulator(s).

**Transitional Academic Eligibility**

- a. All candidates who are applying for a Programme of study for a degree or diploma and are, in the process of acquisition of academic eligibility as mentioned herein above (application made under 'appearing' criteria), shall ensure that documentary evidence of their acquisition of such academic eligibility is brought to the notice of 'Departmental Admission Committee' before the cut-off date as provided under these rules.
- b. where, any candidate having made application for admission to a Programme of study for a degree or diploma under transitional academic eligibility as indicated hereinabove, fails to produce documentary evidence to the satisfaction of 'Departmental Admission Committee' on or before the cut-off date, his/her application for admission shall be summarily rejected unless the context provides for otherwise.  
*Provided that;* where, such a candidate has been granted 'provisional admission' on the recommendation of 'Departmental Admission Committee' and where, he/she fails to submit documentary evidence to the satisfaction of such 'Departmental Admission Committee' on or before commencement of 'End Semester Examinations for the First Semester of that Programme', the provisional admission shall be withdrawn/cancelled without prior notice.
- c. It shall be the duty of the candidates making application under 'transitional academic eligibility criteria' to produce documentary evidence to the satisfaction of 'Departmental admission Committee' and university shall not be liable to give in term information or reminders pertaining to final acquisition of academic eligibility by such candidates.

**Temporary Discontinuation of Academic Study**

a. where, an applicant has attained academic eligibility as prescribed above, in any academic session other than the immediately preceding academic session such candidates shall be required to produce an undertaking in lieu of such '*Temporary discontinuation of academic study*' as provided in **Schedule-I-A**.

b. Where, an undertaking in the prescribed format is filed by a candidate in lieu of temporary discontinuation of academic study and where the admission is to be made on the basis of 'Academic Merit', a penalty of 2% reduction in percentage obtained in qualifying examination for every academic session shall be levied on such candidates, subject to a maximum reduction of 10% for a temporary discontinuation for 5, or more years.

c. An undertaking in lieu of 'temporary discontinuation of academic study' as provided hereinabove, shall be filed by the candidates on an e-Stamp/Stamp on INR 10/- (non-judicial) issued by a notified authority under the provisions of Indian Stamps Act, 1899 or any other law for the time being in force.

**7. Requirements in addition to Academic Eligibilities**

a. Admission to any applicant shall not be permissible if, the applicant has been convicted for any offence or an act involving moral turpitude or civil discipline by any court in India. There shall be compulsory disclosure in relation to this in the admission form.

b. Admission to applicants; who have been dismissed or rusticated or expelled by any University or College or any Higher Educational Institution, or whatsoever grounds, shall not be permissible under any circumstances.

c. 'Canvassing' in any form by the candidates seeking admission to a Programme of study for a degree/diploma under the administration of University, shall lead to summary cancellation of their candidature, on appropriate recommendation by 'Departmental Admission Committee'.

d. Every candidate seeking admission to a Programme of study for a degree or diploma of the University, should make himself/herself aware of the objectives of the University as prescribed by Dr. Shakuntala Misra National Rehabilitation University Act, 2009 and shall accordingly be bound for compassionate behavior with students of special needs (Divyangjan) according to understanding of a person of ordinary prudence.

e. The university reserves the rights to cancel admission and to pursue appropriate legal proceedings against candidates at any stage of a Programme of study for a degree or diploma; if acts or omissions concerning any or all of the requirements indicates hereinabove, are brought to the notice of concerned authorities.

**PART III: MODES OF ADMISSION**

**Mode of admissions**

a. All admissions to the programmes administered by all departments of the university will be taken through Common University Entrance Test (CUET) which is conducted by National Testing Agency (NTA).

**Note:** There shall be another mode of admission to all the Programmes of study for UG, and PG i.e. on academic merit basis for any Academic Programme provided that the seats remain vacant after CUET UG and PG counselling.

b. The university reserves right to change the mode of admission to any Programme of study for a degree or diploma **at any stage** pursuant to grave and unavoidable circumstances (such as COVID-19 or any other natural disaster), or on order of competent authorities of Central or State governments, or on the recommendation of any other authority specifically empowered to do so in this behalf.

c. Notification/Notices regarding change of mode of admissions for any Programme of study shall be published on the University's website for general information of the candidates.

**Admissions on the Basis of CUET Merit/Academic Merit'**

- a. Where, admissions on the basis of 'academic merit' in qualifying examination will be undertaken, such 'academic merit' will be published from among the total applications received for admission to a particular academic programs under such department/ faculty.
- b. On the basis of CUET Merit.
- c. The concerned Admission Committee (UGPG)' will announce a 'Cut-off Date' preferably at least 4-5 days before the publication of First Merit List' and shall provide appropriate opportunity to the candidates having applied under "transitional academic eligibility' criteria as provided for under Rule 4 heruinaabove.
- d. The merit lists for admissions shall be published by the Admission Committee (UG/PG)' after proper implementation of Reservation Policy and weightage for various categories. It shall be the duty of each such committee to prepare and publish 'category-wise' merit list for each category of candidates availing benefit of reservation.

*Provided that*, in cases where reservation has been claimed by an applicant but any legitimate document(s) in respect thereof, has not been submitted with the application form, such applicants shall be considered in 'Open/UR' category.

*Provided further that*, it shall be the duty of applicants to carefully check entries made by them in the application form and documents submitted alongwith the application form.

- e. Such 'academic merit' shall be based on Percentage of Marks' obtained by the candidates in 'Qualifying Examination' indicated as a minimum academic eligibility and other academic weightage earned by the candidates, for admission to an academic program.

*Provided that*, a list of academic weightage awarded to candidates having claimed such benefit will also be published by the Admission Committee (UGPG) together with the academic merit.

*Provided further that*, in case of any discrepancy, appropriate representation may be made by the candidates to the Chairperson' of the 'Admission Committee (UG/PG)' who shall dispose such representation as early as before the publication of Second Merit List'.

- f. Where a candidate had applied for admission on the basis of 'transitional academic eligibility', such candidates will be considered only when they adhere to the requirements as listed under Rule 04 of these Rules.
- g. Any candidate aggrieved of such disqualification may make a representation to the Chairperson of the Admission Committee (UGPG)' within 03 days from the date of publication of the First Merit List'.
- h. The decision taken by such Chairperson of the Admission Committee (UG/PG) shall be final and binding.

*Provided that*, no such decision could be made without providing a reasonable opportunity of being heard to the concerned candidates.

### **Special Provisions for Differently-abled Students (Divyangjan)**

- a. Whereas, the university provides 50% reservation to the students with special needs.

*Provided that*, such benefit shall be extended to candidates who have submitted appropriate documentary proof of disability along with the application form.

*Provided further that*, benefit under this rule will be at the discretion of the university and shall not be a matter of right.

b. 'Benefit of adjustment' as contained here in above, shall be available only for the purpose of preparation of 'academic merit' and shall not be extended to other monetary or non-monetary benefits which are or may be provided to students with special needs from the state of UP.

c. Any discrepancy in this regard should be brought to the concern of Chairperson of the 'Departmental Admission Committee' within a reasonable period of time.

- d. The decision taken by the Chairperson shall be final and binding in this regard.

### **Tie-Breaker Rules for Presentation of Academic Merit**

a. Where, during preparation of academic merit, the cumulative marks of two or more candidates are tied due to similarity, they shall be placed in order of merit as per the rules contained in these Rules and not under any other rules(s) for the time being in force.

- b. The tied scores among candidates shall be awarded merit as per the following tie-breakers.

- I. First preference would be given to the candidate who has secured higher marks at preceding examinations/ degrees
- II. If the marks secured in preceding examinations are also same, first preference would be given to the candidate securing higher marks at High School or Class X or Matriculation level of examination.
- III. If the marks secured at High School or class X or Matriculation Examination are also same, then first preference would be given to the candidates eldest in age according to date of Birth indicated on such High School or Class X or Matriculation examination mark sheet.

### **Miscellaneous Provisions relating to Academic Merits**

a. Academic Merits shall be prepared by the 'Departmental Admissions Committee' for each separate Programme of study for a degree or diploma under the Department.

b. In case of any inadvertent error or mistake having been discovered a fresh 'corrigendum' shall be published by the committee on the university website indicating errors and suitable corrections made for rectification of such errors.

c. After the announcement of 'Cut-off' date by the Department Admissions committee, application by any candidate shall not be considered for the purpose of preparation or merit list, on whatsoever grounds.

d. The merit lists shall be treated as ‘Provisional Qualification’ for admission and shall be subject to physical verification of all testimonials and documents by the Departmental Admissions Committee.

e. After publication of merit lists, each Departmental Admission Committee shall publish notices for admission counseling through which physical verification of all documents and academic testimonials shall be done with strict care and caution.

*Provided that*, admission counseling will be called preferably within 03 days from the date of publication of merit list and not later.

f. Where, there appears a conflict or mismatch between the records forwarded with application from and records presented at the time of physical verification of documents and related testimonials, such candidates shall not be considered for admission through the merit list concerned and shall be put to ‘waitlist’ till final decision is made by the Chairperson after a reasonable opportunity of being heard is provided to such concerned candidates(s).

g. All eligible candidates who fail to appear for admission counseling. For whatsoever reasons, on the date as notified by the Departmental Admission Committee, shall be recalled for counseling after publication of all merit lists by such committee and not earlier, through a separate counseling notice, if there remain any vacant seats for allotment.

h. Every Departmental Admission Committee shall have power to award 15 days ‘Grace Period’ for candidates to submit marksheets in case provisional marks statements are submitted), degree certificates, migration certificate (if applicable), Transfer Certificates etc on careful perusal of the circumstances.

*Provided that*, grace period should be awarded only if the conditions so warrant and the same should not be a clumsy exercise of discretion.

i. Any discrepancy or error(s), should be reported to the Chairperson as early as possible by the concerned candidates.

**Miscellaneous Provisions relation to Registration Forms after CUET (UG/PG)/ Merit Basis**

a. Entries made to registration forms by the candidates, will only be considered for the purpose of standard procedures for admissions. Candidates are accordingly advised to check entries made in the form, multiple times before final submission.

b. Candidates should upload clear, legible and most recent documents in the required format, for the purposes of admission through online portals. Incomplete, unclear entries may lead to disqualification of candidature.

c. Candidates should make themselves aware of the rules relating to discipline, conduct, examinations, hostels etc., before proceeding with the application form submission of an application form would imply acceptance to such rules and regulations, for the time being in force.

d. Candidates should submit separate application forms for separate Programme of study, Subsequent transfer/changes etc. will not be allowed on any ground, whatsoever.

e. Candidates are advised to browse for information from the university website only, and should not get misguided by any other source which may publish information without the knowledge of university admission.

f. Candidates are advised to provide ‘Certificate relating to Reservation’ issued by competent authorities as per government guidelines only, such certificates should have been issued preferably within 01 year preceding the date of making application for admission to a Programme of study.

g. Incomplete entries will lead to cancellation of the application form.

h. Candidates should satisfy themselves regarding eligibility criteria for the purposes of admission to a Programme of study. The academic eligibility would be adjudged from the date of making application for admission.

*Provided that*, for transitional academic eligibility as referred in Rule 04 hereinabove; all application will be provisionally considered subject to final acquisition of eligibility to the satisfaction of concerned ‘Departmental Admission Committee’.

i. Candidates are advised to communicate with the university authorities only in the requirements of urgency. Irrelevant or unnecessary communication will not be answered.

j. Registration/Admission fee, once shall not be refunded in any case, whatsoever. Candidates are advised to follow the application related guidelines while filling up the online admission form.

**Publication of Merit Lists on CUET Scores / Merit Basis**

➤ The merit lists for admissions shall be published by the ‘Department Admissions Committee’ after proper implementation of reservation policy and weightage for various categories. It shall be the duty of each such committee to prepare and publish ‘category-wise’ merit list for each category of candidates availing benefit of reservation.

*Provided that*, in cases where reservation has been claimed by an applicant but any legitimate document(s) in respect thereof, has not been submitted with the application form, such applications shall be considered in ‘Open/UR’ category.

*Provided further that*, it shall be the duty of applicants to carefully check entries made by them in the application form and documents submitted along with the application form.

*Provided that*, a list of academic weightage awarded to candidates having claimed such benefit will also be published by the 'Departmental Admissions Committee' together with the academic merit.

*Provided further that*, in case of any discrepancy, appropriate representation may be made by the candidates to the 'Chairperson' of the 'Departmental Admission Committee' who shall dispose such representation as early as before the publication of 'second merit list'.

➤ Where a candidate has applied for admission on the basis of 'transitional academic eligibility' such candidates will be considered only when they adhere to the requirements as listed under Rule 04 of these Rules.

➤ Any candidate aggrieved or such 'disqualification' may make a representation to the Chairperson of the 'Departmental Admissions Committee' within 03 days from the date of publication of the 'First Merit List'.

➤ The decision taken by such Chairperson of the Departmental Admissions Committee shall be final and binding.

➤ *Provided that*, no such decision could be made without providing a reasonable opportunity of being heard to the concerned candidates.

### **Sports Quota Admission**

Admission may be given to National and International players (only those certified from recognized bodies) in case they do not qualify in the merit list, after approval from the University Sports Committee on the recommendation of the Directorate of Sports. A maximum of 05 percent of the allotted seats per course may be considered as extra seats for such admissions. Such students shall have to give an undertaking at the time of admission to the Director of Directorate of Sports stating that they will take part in the State/National/ International tournaments. Any student found not serious in the practice and if they do not participate in the State/National/ International tournaments, University has right to cancel all their benefits related to the sports activities and they will be treated as non-sports students. (Sports Quota is applicable only for courses run under the non-regulatory bodies)

### **Grievances relating to Reservation**

a. All representations relating to applicable reservation for various categories shall be addressed to the Vice-Chancellor through the University Admission Committee after perusal of appropriateness.

b. Decision of the Vice-Chancellor/University Admission Committee, in this regard shall be final and binding on all candidates seeking admission to a Programme of study.

### **Regarding refund of admission fee –**

If any candidate decides to withdraw from the course in which he/she took admission, then the below-mentioned system of the UGC norms for fee refund will be applicable :

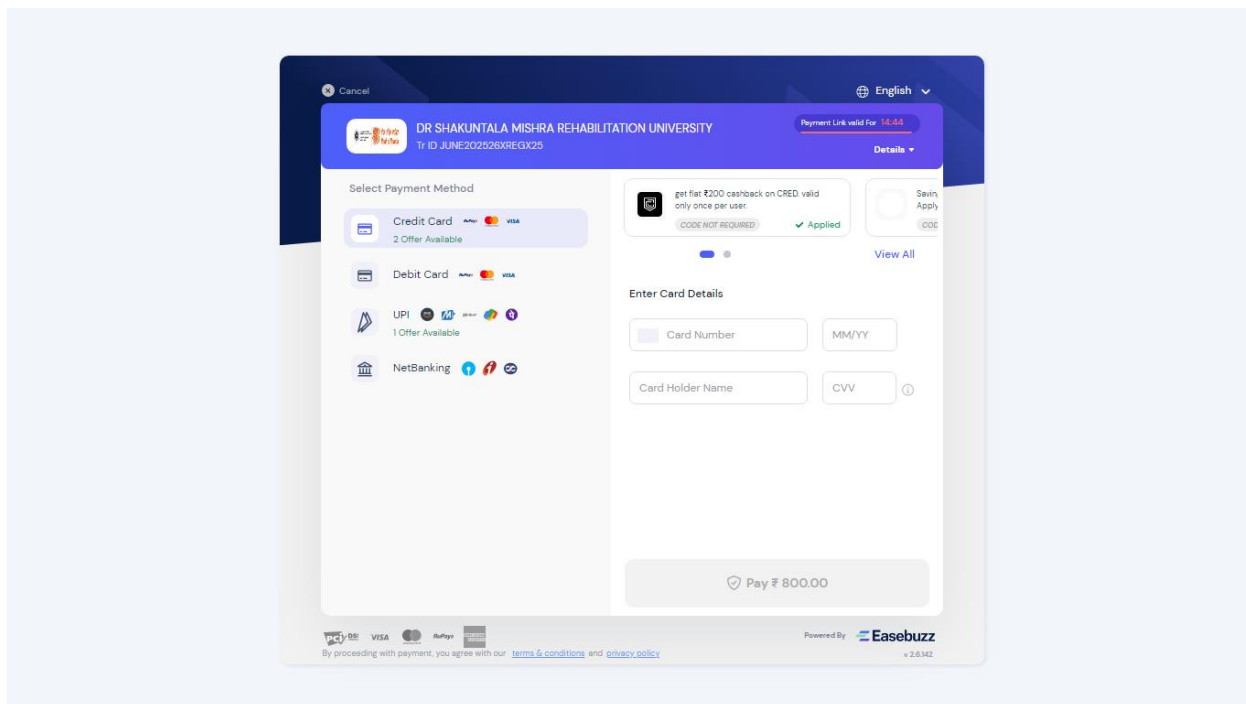
