Dr. Shakuntala Misra National Rehabilitation University, Lucknow Postgraduate (PG) Programmes Regulation - 2024

This Regulation shall be known as "Dr. Shakuntala Misra National Rehabilitation University, Lucknow Postgraduate Programmes Regulation – 2024" and shall provide the Programme structure of one/and two year PG Programme adhering the guidelines of Curriculum and Credit Framework for Postgraduate Programme (CCFPGP) issued by UGC on 12 June 2024 and National Higher Education Qualification framework (NHEQF) issued by UGC on 20th April, 2023 under NEP - 2020 and shall come into effect from the date it is duly notified by the University.

1. Short title and Application

This Regulation shall be called as "DSMNRU PG Programmes Regulation-2024" and shall apply to Postgraduate Programmes in the Faculty of Arts, Humanities and Social Science, Faculty of Language, Faculty of Commerce, Faculty of Fine Arts and Performing Arts, Faculty of Management and Faculty of Science. The Programmes in the Faculty of Special Education, Law, Paramedical and Rehabilitation Sciences, Engineering & Technology, Pharmacy etc. shall be governed by adhering the guidelines issued by their respective regulatory bodies under NEP - 2020 along with this Regulation.

2. Main Features under CCFPGP

- i. Flexibility to move from one discipline of study to another;
- ii. Flexibility for students who qualify UG with a major and minor (s) to opt for either major or minor(s) subject or any other subject if they are able to prove their competence in PG Programme;
- iii. Opportunity for students to choose the courses of their interest;
- iv. Flexibility to switch to alternative modes of learning (offline, ODL, Online learning, and hybrid modes of learning);
- v. Mobility and flexibility as per the UGC (Establishment and Operation of Academic Bank of Credits in Higher Education) Regulations, 2021, and UGC Guidelines for Multiple Entry and Exit in Academic Programmes already in place.

3 Definitions of key words

- 3.1 Academic Year: The annual period of study consists of two consecutive semesters, (one odd semester and one even semester) which essentially starts from the odd semester shall constitute one academic year.
- 3.2 Semester: Each semester will consist of academic work equivalent to 90 working days including examination/evaluation. The odd semester will start from July/August to December and even semester from January to May in each academic year. N. K. Sington

- 3.3 Choice Based Credit System (CBCS): The CBCS provides choice for students to select the courses of their interest to study from the prescribed courses to complete the credit requirements for the Certificate, Diploma or Degree in a Programme.
- **3.4 Programme**: The systemic academic scheme of study of courses through teaching, learning and evaluation for earning the prescribed credits during prescribed numbers of academic year leading to award of a Certificate, Diploma or Degree shall be called "Programme."
- **3.5 Discipline/Subject:** An Umbrella of the academic knowledge evolves with the bunch of courses/ or papers for the study in a Programme.
- **3.6 Course:** also known as paper, is a sub component of a discipline/ subject and may include lectures/ tutorials/ laboratory work/ field work/ outreach activities/ project work/ dissert action/ vocational training/ seminars/ term paper or skill enhancement/ ability enhancement/ value addition/ Internship a combination of some of these.
- **3.7 Credit:** A unit by which the weightage of course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one hour of teaching (lecture/ tutorial) or two hours of practical work/ field work per week.
- 3.8 Grade Point: It is a numerical value allotted to marks obtained in a course.
- **3.9 Grade**/ **Score Card:** The grade cards will be given to all students at the end of any semester of a Programme and also after improvement of grades. It will display the course details (code, title, number of credits, grade points) obtained in each course and SGPA/CGPA.
- **3.10 Semester Grade Point Average (SGPA):** It is a measure of academic performance in a semester.
- **3.11 Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative academic performance of a student.
- **3.12 Award Sheet**: The final award sheet shall be issued on successful completion of all semesters of a Programme, which, will display the course details (code, title, number of credits and grade points) obtained in each course, SGPA and CGPA.
- 3.13 Academic Session (or Session): One academic year shall represent the Session e.g. if the odd semester of the academic year starts in the month of July/August of calendar year 2024 and the consecutive even semester ends in the month of May of calendar year 2025, then that very academic year shall be represented by the Session 2024-25.
- 4 Eligibility criteria for the PG Programme
 - **4.1 1-year PG Programme:** The candidate having a bachelor's degree with Honors/ Honors with Research with a minimum of 160 credits.

4.2 For 2-year PG Programme: The candidate having a 3-year/6-semester bachelor's degree with a minimum of 120 credits.

- **4.3** The candidate having a 4-year Bachelor's degree (e.g. B.E., B. Tech. etc.) with a minimum of 160 credits shall be eligible for a 2-year/4-semester PG Programme (e.g. M.E., M. Tech. etc.).
- **4.4** A student is eligible for a PG Programme in a discipline corresponding to either major or minor(s) discipline in UG Programme. In this case, the University can admit the students in the PG Programme based on the student's performance in the UG Programme or through an entrance examination.
- **4.5** However, irrespective of the major or minor disciplines chosen by a student in a UG Programme, a student is eligible for admission in any discipline of PG Programmes if the student qualifies the National level or University level entrance examination in the discipline of the PG Programme.

5. Types and title/nomenclature of qualifications

The National Higher Education Qualification Framework (NHEQF) describes the outcomebased framework for qualifications of different types. The qualification types and examples of title/nomenclature for qualifications within each type are indicated in Table 1.

Programme duration: five years (ten semesters) after successfully completing secondary education (Grade 12 of school education) Master of Education (M.Ed.). Programme duration: Two years (four semesters) after completing a 2-year/4-semester B.Ed. degree programme or a 4-year (8 semester) dual-degree integrated teacher education programme. Integrated B.Ed M.Ed. Programme. Programme duration: Three years (six

- Master of Engineering (M.E), Master of Technology (M. Tech.). Programme duration: Two years (four semesters) after obtaining a Bachelor's degree inengineering/technology.
- Master of Architecture. Programme duration: Two years (four semesters) after obtaining a B. Arch degree

6. Curricular Components as per CCFPGP of UGC

For 2-year PG Programmes: Students entering 2-year PG programme after a 3-year UG programme can choose to do (i) only course work in the third and fourth semester or (ii) course work + research in the third and fourth semester or (iii) only research in the third and fourth semester.

1-year PG: Students entering 1-year PG after a 4-year (Hons) UG programme will do course work Ist and IInd semester and can choose to do (i) only coursework or (ii) coursework + research or (iii) research.

Exit Point:

For those who join 2-year PG Programmes, there shall only be one exit point at the end of the first year. Students who exit at the end of 1st year shall be awarded a N. Y. Zillyon Postgraduate Diploma.

8. Structure of PG Programme in this University

Under the CCFPGP of UGC as detailed in clause 6 and 7 of this Regulation, the Programme Structure of 2-year and 1-year PG Programme in this University shall be as follows:

Note – *Mid Term Evaluation of Dissertation/Research thesis/Project shall be done in III semester and final evaluation shall be done in IV semester of 02-year PG Programme. Mid Term Evaluation of Dissertation/Research thesis/Project shall be done in I semester and final evaluation shall be done in II semester of 01-year PG Programme.

9. Switching Subjects in Postgraduate Programme

The first degree often makes students think of a different career path that requires a change of subject. Changing direction with a postgraduate degree has its challenges, but NEP gives enough freedom to make it a possibility. The postgraduate Programmes provide an opportunity for students to change the field and realize their vision, as per the pathways given below:

a) A student is eligible for admission in a PG Programme either in the major or minor discipline taken by the student in his/her UG Programme.

b) Irrespective of the major or minor disciplines taken by a student in a UG Programme, a student is eligible for admission in any discipline of PG Programmes if the student qualifies the National level or University level entrance examination in the discipline of PG Programme.

Candidates who have completed 4-year UG Programme or a 3-year UG and 2-year PG Programme or 5-year integrated Programme (UG + PG) in STEM subjects will be eligible for admission in M.E., M. Tech. in allied areas.

- 10. Admission Procedure. University shall notify an Admission-Brochure well in advance on the University website specifying the subject/discipline-wise number of seats for admission, criteria for admission, the procedure for admission, and all other information relevant for the candidates. The admission of Indian nationals to the 2-year/or 1-year PG Programmes shall be based on merit determined on the basis of performance in the qualifying examination as detailed in clause 4.0 of this Regulation/ or the Postgraduate Entrance Test/CUET-PG whichever is opted by the University from time to time. However, Foreign Nationals applying for admission through authorized channels shall be eligible for direct admission on super numeric seats. Affiliated colleges may design their own admission process without diluting the minimum eligibility required for admission with the approval of the University.
 - a) Reservation Policy: Reservation policy in admission prescribed as per the Act & Statute of the University and the policy of U.P. Government shall be
 - The Scheduled Castes/ Scheduled Tribes/ Other Backward Classes (Non-Creamy layer)/ EWS candidates originally belonging to Uttar Pradesh will be given the benefit of reservation. Scheduled Castes/ Scheduled Tribes/ Other Backward Classes/EWS candidates of other States will be treated as Unreserved category.
 - b) Order of Merit: If two or more candidates have secured equivalent marks/ rank in the merit Index of Entrance Test/CUET-PG, then the merit for admission will be determined as follows:
 - (i). The candidate, who has secured higher percentage of marks at UG examination will be given preference.
 - (ii). If the marks secured at UG examination are the same, in such cases first preference will be given to the candidate who has secured higher percentage of marks at Intermediate (10+2) or equivalent examination.
 - (iii). If the marks obtained at the Intermediate (10+2) or equivalent examination are also the same, then in that case first preference will be given to the candidate who has higher percentage of marks at High School equivalents examination.
 - (iv). If the marks obtained at the High School or equivalent examination are also the same, then in that case the elder candidate (as per the date of birth) will be given
 - 10.1 Declaration of result: Merit list for admission shall be published on the official website of Dr. Shakuntala Misra National Rehabilitation University, Lucknow.

10.2 Weightages

Weightages for admission shall be according to the rules of the University.

11. Duration of the Programme

- The duration of the 2-year/4 semester PG Programme is 2-years/4 semesters as reflected from its name and the maximum duration to complete the Programme shall be 4 years. If a student wants to exit after the completion of the first year, then he/she will be given a PG Diploma provided he/she secures the prescribed number of credits and fulfills the condition prescribed in this Regulation.
- Students who exit with a PG diploma are permitted to re-enter within 1-year and complete the Programme provided the total duration for completing the Programme should not exceed to 4 years.
- iii. The duration of 1-year/2 semester PG Programme is 1-year/or 2 semesters as reflected from its name and the maximum duration to complete the programme N. K. Singhorm shall be 2-years.

12. Exit and Entry Points

- 12.1 In case the student wishes to exit after completion of 1-year of the 2-year PG Programme, he/she shall be eligible for award of a PG Diploma provided the student fulfils the following conditions:
 - a) Has pursued the prescribed courses of study and has completed 40 credits as prescribed under this regulation without 'F' or 'Ab' in any course.
 - b) Has completed, in addition, a skill enhancement course/internship/vocational course of 4 credits during the summer vacation after the second semester; otherwise he/she shall not be eligible for re-entry in the future.
 - c) Obtained a minimum CGPA of 4.0
 - d) Paid all the dues of the University.
 - e) No disciplinary proceedings are pending against him/her.
 - f) Any other condition, as notified by the competent authority of the University.

12.2 Lateral Entry

Lateral entry for the candidate with PG Diploma shall be allowed in the beginning of the 3rd semester on the vacant seats in the programme/ or over and above the 10% of the sanctioned seats whichever is larger.

13. Examination(s) and Assessment / Evaluation

- **13.1** In the course work, there shall be continuous internal assessment and Semester-end Examinations as per the scheme of Examination.
- **13.2**The continuous internal assessment shall have a weightage of 25 marks. The internal assessment of the students may include a written test carrying 15 marks and an assignment /presentation/projec carrying 10 marks.
- 13.3 It shall be the duty of the teacher/ teachers teaching a particular course, to conduct internal assessment, evaluate and award marks.
- **13.4** The evaluation of course work in the End semester examination of 75 marks shall be either descriptive or in MCQ mode (depending on the policy of the University).
- 13.5 Major Research Project/Dissertation carrying ten credits will be evaluated in the 4th semester of 2-year PG and second semester of 1-year PG Programme respectively. The student is required to submit the major research project/dissertation along with the requisite certification from the concerned supervisor. However, Mid Term Evaluation of Dissertation/Research thesis/Project shall be done in III semester of 02-year PG Programme and in I semester of 01-year PG Programme.
- **13.6** The supervisor allotment will be decided by the Departmental Committee as per the provisions of the statutes of the University.
- 13.7 The panel for evaluation of dissertation (carrying 75 percent weightage) and the presentation by the student and viva-voce (carrying 25 percent weightage) shall consist of the supervisor and one external examiner approved (by the University.

- 13.8 The assessment/ evaluation of each course will be out of 100 marks (25 for internal assessment and 75 for end of semester examination) irrespective of number of credits allotted to the course.
- 13.9The marks shall be converted to grades as per the criteria given in table-5 of this Regulation.
- 13.10 The University shall permit the credit transfer as per rules framed by the University.
- 13.11 If a course of any subject (both theory and practical) is a credit course, then the passing percentage for each shall be 40 %. CGPA of 4.0 (aggregate 40% marks) shall be required for passing a Programme.
- 13.12 There is no minimum or separate passing percentage for internal evaluation.

14. Promotion and Reappearing

- a) All students shall be promoted automatically from odd to even semesters.
- b) A student shall be promoted from any academic year to the next if he/ she has passed in at least fifty percent credit courses in previous two semesters combined.
- c) Those students who are NOT eligible for promotion shall have to reappear in the end semester examination of those courses in the semester(s) in which the student has failed, within the next regular examination only. The grades of internal assessment shall carry forward in such cases.
- d) Those students who are eligible for promotion and wish to improve their grades. may choose to reappear in the end of semester examination to improve their grades, within the next regular examination only. The grades of internal assessment shall carry forward in such cases.
- e) A student may be allowed to re-register for a semester, within the maximum stipulated time period allowed to complete the program, provided he/ she satisfies one of the following conditions. In such a case there shall be fresh assessment of internal evaluation:
 - i. The student is declared fail.
 - ii. The student did not appear in a semester-end examination or he/ she was not granted permission to appear in the examination.
 - iii. The student had been detained by the University and subsequently has been permitted to take re-admission.
 - iv. The student has own desire to abandon the performance of the semester and wishes to repeat/reappear.
- f) Those students who reappear in any course (s) in any semester or re-register for a semester, shall have to pay the prescribed fee.
- g) Cases of use of unfair means in the examination shall be dealtwith as per the rules and regulations of the University.
- h) Challenge evaluation shall be permitted as per rules/ orders of the Vice Chancellor.

14.1 Grade Card

Page | 10 A grade card shall be issued to each student at the end of every semester subject to fulfilment of all other conditions.

14.2 Transcript

A Transcript shall be issued to a student on successful completion of the Programme on request by the student after paying the required fee as per university rules.

14.3 Withholding of Grade Card/Transcript

The Grade Card/ Transcript of a student shall be withheld if he/she has not paid his/her dues, or if there is a case of indiscipline pending against him/her.

14.4 Grading

- a) A student obtaining grades 'P' to 'O' (numeric grade 4 or higher) in any course shall be considered PASS in that course.
- b) For non-credit courses, P or F will indicate Pass or Fail.
- c) If a course of any subject (both theory and practical) is a credit course, then the passing percentage for each course is set at 40 percent. There is no minimum passing percentage for internal evaluation. Even if a student scores zero marks in internal evaluation and meets the minimum passing criteria in semester examinations, they will be considered as pass.
- d) A student shall be eligible for a maximum of seven grace marks in only one course provided he/she is able to pass the semester with the help of this grace marks. For the ease of computation, the assessment/evaluation of each course will be out of 100 marks (25 for internal assessment and 75 for end of semester examination) irrespective of number of credits allotted to the course.

When students take audit courses, they may be given pass (P) or fail (F) grade without any credits.

15. Computation of SGPA and CGPA

The Semester Grade Point Average (SGPA) is computed from the grades as a measureof the student's performance in a given semester. The SGPA is based on the grades of the current term, while the Cumulative GPA (CGPA) is based on the grades in all coursestaken after joining the Programme of study.

The UGC recommends the following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

The SGPA is the ratio of the sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits N.K. Zingon of all the courses undergone by a student, i.e.

SGPA (Si) = \sum (Ci x Gi) / \sum Ci

Where Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

The Cumulative Grade Point Average (CGPA) is also calculated in the same manner taking into account all the courses under gone by a student over all the semesters of a Programme, i.e.

where Si is the SGPA of the 1th semester and Ci is the total number of credits in that semester.

The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.

Transcript (Format): Based on the above recommendations on Letter grades, grade points and SGPA and CCPA, the University may issue the transcript for each semester and a consolidated transcript indicating the performance in all semesters.

16. Award of Division

Table: 6 Division shall be awarded to the students as per the following table:

CGPA RANGE	Division
≥ 7.5	First Division with distinction
≥ 6 < 7.5	First Division
≥ 4.5 < 6	Second Division
≥ 4 < 4.5	Third Division

Note: The conversion formula for converting CGPA to the corresponding Percentage(P) of Marks will be as follows:

Percentage of Marks = $CGPA \times 10.0$

The merit rank of the students shall be determined on the basis of the CGPA obtained by them. However, only those students who have passed all courses in the first attempt without grace marks, shall be eligible for the award of medals.
