Sign Language Interpreter will be empanelled till 30<sup>th</sup> June, 2027 or filling up of posts through regular recruitment or till further orders, whichever may be earlier. The empanelment will be purely on honorarium basis and no claim for regular appointment shall be entertained by the University at any time.

Interested and eligible candidates are required to report for Walk-in-Interview at their own expense at the office of Registrar situated at the 04<sup>th</sup> Floor admin block Conference Hall as per schedule to be published on the website of the University along with the following documents:

1. Original certificates of relevant degrees and experiences with two sets of photocopies.
2. Three passport size photographs with proof of identification.

**Important Instructions:-**

1. Interested and eligible candidates are requested to fill the prescribed Application Form and bring the same with all the annexure along with original certificates and testimonials for personal interview, as per schedule indicated above.
2. The number of posts may increase or decrease.
3. **Schedule of Interview shall be displayed on the university website.**
4. The maximum age limit for applicants shall be 60 years.
5. Candidates are required to bring a bank draft of Rs. 500/- drawn in favour of Finance Officer, DSMNRU Lucknow, self attested photocopies of relevant degree and experience certificates, publications, passport size photographs along with proof of identification at the time of Interview, failing which they shall not be allowed to appear in the interview.
