# **Educational Qualification:**

For Professor Mechanical Engineering/Computer Science & Engineering/Electronics and Communication Engineering/Electrical Engineering/Civil Engineering:

a. Ph. D. degree in relevant field and First class or equivalent at either Bachelor's or Master's level in the relevant branch of concerned/relevant/allied department.

#### **AND**

b. Minimum of 10 years of experience in teaching / research / industry out of which at least 3 years shall be at a post equivalent to that of an Associate Professor.

#### **AND**

c. At least 6 research publications at the level of Associate Professor in SCI journals / UGC / AICTE, approved list of journals and at least 2 successful Ph.D. guided as Supervisor / Co- supervisor till the date of eligibility of promotion.

OR

#### For Assistant Professor Environmental Science:

- (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a Environmental Science/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET: Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions: -
- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The candidates registered for Ph.D. Programme after July 11, 2009 have to attach a compliance certificate for the fulfillment of the provisions of UGC (Minimum Standards and Procedure for the award of Ph.D. Degree) Regulations, 2009 issued by the competent authority of the University.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

**Note:** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

B. The Ph. D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai). - i) An eminent scholar having a Ph.D. degree in the Physics/allied/relevant subject, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2 UGC Regulations –2018 on <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>
- ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

B. An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) /industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

# **General Instructions**

- Dr. Shakuntala Misra National Rehabilitation University is following the qualification in accordance with Dr. Shakuntala Misra National Rehabilitation University Act, 2009/UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018/ AICTE (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2019// Rehabilitation Council of India, New Delhi.
- 2. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes/OBC-Noncreamy Layer)/ Differently-abled [(a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness)] for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 3. A relaxation of 5% shall be provided (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19th September, 1991. NET/SLET/SET shall not be required for such Master's Degree Programmes in disciplines for which NET/SLET/SET accredited test is not conducted.
- 4. Online mode of submission of applications shall be essential. Candidates are advised to satisfy themselves before applying that they possess at least the minimum essential qualifications laid downin the advertisement.
- 5. The number of post/s may increase or decrease as per reservation roster.
- 6. Applicants shall first register on the recruitment portal, after which, they can fill up the prescribed application form online. Separate applications shall be submitted for different positions.
- 7. Before starting to fill up the form, please ensure that you have the following: A scanned copy of photograph, signature, relevant caste certificate (if any), Income certificate regarding EWS (if any), certificate for PwDs (if any), educational qualifications and experience related documents in JPEG/JPG/PDF format. The photograph and signature shall be in JPEG/JPG format between 20 kb and 50 kb and other documents in JPEG/JPG/PDF format between 100 kb and 300 kb.
- 8. While filling the online application, if the browser closes unexpectedly or if the candidate is logged out, he/she may use the login information sent to his/her e-mail to login again.
- 9. Enter all your research publications and other Academic/Research contributions in the online application. Only the information entered in the online applications will be taken into account for deciding eligibility and/or short listing. Uploading digital copies of publications is essential. Filling all mandatory fields is required to make your application complete.
- 10. Incomplete applications will not be considered and will be rejected.

- 11. There are several Tabs in your application. After completing each tab, you should click on 'Save' button to save the information and move to the next tab. After filling all tabs, the candidate can finally submit his/her application. Please note that you cannot make any changes after submission.

- 13. The applicant will come across a link for paying application fee and after the Payment, the candidate can apply online, download a PDF of the application, which he/she will have to print and send to the University after signing it and having it forwarded by his/her employer, if any, enclosing therewith the copies of the relevant certificates and documents, so as to reach DSMNRU by the cut-off date and time.
- 14. Please note that sending the duly signed printout of the PDF along with all enclosures is mandatory without which the applications may not be considered for further processing. Candidates must send self- attested copies of certificates, mark-sheets from matriculation (10th Standard)onwards in support of the qualifications, experience, reprints of publications and certificates in support of their research score claimed for teaching positions along with the hard copy of the application form.
- 15. Mere eligibility will not entitle any candidate for being called for interview. More stringent criteria may be applied for short-listing the candidates to be called for interview. Applicants having higher qualification and merit will be given preference. Good Academic Record for all teaching positions shall be as defined in the concerned Ordinance.
- 16. The selection process will consist of exam/interview for the post of Assistant Professor.
- 17. All such applicants whose result/grade card is in Grade Points/CGPA/OGPA/SGPA will have to enclose a Certificate from the Registrar/ Concerned Authority clearly stating the conversion formula for calculation of the equivalent percentage.
- 18. Relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by a recognized University shall also be considered eligible.
- 19. The horizontal reservation shall be provided as per the applicable State Govt. Policy. Candidates belonging to SC/ST/OBC/EWS/PwDs category should submit relevant certificate as per the proforma prescribed by the Govt.

- 21. Relaxations and concessions for SC/ST/OBC/EWS/PwDs will be applicable in accordance with the applicable reservation policy and subsequent clarification/directives issued from time to time to this effect. The relevant OBC Certificate must have been issued within the last six months only and must clearly state whether the candidate belongs to creamy or non-creamy layer.
- 22. Applicants not belonging to the State of Uttar Pradesh shall be treated as Unreserved Category and will not be entitled to any benefit of reservation.
- 23. The eligibility of an applicant shall be determined in accordance with the relevant regulations of concerned Regulatory bodies /Act/Ordinance.
- 24. The University shall verify the antecedents or documents submitted by a candidate at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedent/ background and has suppressed the said information, then his/her services shall be terminated.

- 25. Where an applicant requests, for good and sufficient reasons, to be considered in absentia, the Selection Committee may, with the approval of the Vice- Chancellor, so consider him/her, for the post of Professor, the Selection Committee may, with the approval of the competent authority-The Vice Chancellor, consider in absentia, the names of eminent persons who have not submitted such application.
- 26. The University reserves the right to withdraw any advertised post(s) at any time without giving any reason. The University may, at its discretion, fill up any future vacancy belonging to UR/EWS/SC/ST/OBC(NCL)/OBC/PwDs as per roster point, out of the available candidates. The number of positions is thus open to change.
